1. Action Items

a. SB posted Rosters, Schedule, Standings, Rules, and Player Finder files on their respective website pages **Item closed.**

b. League Equipment

Pitching Screens - need to replace 1 (possibly 2) pitching screens --- tabled until Fall '25 season. Item remains open.

<u>Ball Bags</u> – the two existing ball bags need to be replaced. GS has a bag that will be serviceable as a ball bag, and will bring to the games on 2/3/25 (Subsequent to the Board meeting, on 2/3/25, GS brought his bag to the field for use.) A second ball bag needs to be purchased. **Item remains open.**

<u>Home Plate Mats</u> – GS has held off contacting Tom Jadwin regarding the mats as Jadwin has recently undergone knee surgery. **Item remains open.**

<u>Lineup Sheets</u> – JH received, unsolicited, 106 2-part lineup cards from Tiffany Peck (TiP)/SSUSA and gave the forms to SB for league use. TiP sent JH a text in which she indicated that she has ordered more forms, and will send more to JH when she receives a shipment. For, at least, a second time, JH emailed that he did not want to receive any more forms until he knew the price. JH had communicated the same to TiP prior to receiving the 106 forms. JH has no knowledge as to whether MVUDSS will be invoiced for the 106 forms and will take no overt action to make any such determination. **Item remains open.**

Revisit MVUDSS Rule 8.c regarding "pickup player" rules for end-of-season SE tournaments.

JH read the following in full. This explanation was initially included in the 1/27/24 minutes, repeated in the 1/21/25 minutes, and now in these minutes. The delay in taking any action on the item was to take action on the item when a full Board was present. At this point, that goal will be dispensed with.

The consensus of the Board appeared to be to rescind the revised rule. Further action, such as a motion, was to be tabled briefly and was to be resumed for action after reviewing Item 3.d. below (specifically the season ending tournament). The return to a motion on the rule got "lost" in the press of the agenda schedule and was not formally addressed. This item will be addressed in the next Board meeting).

JH motioned and SB seconded that the revised pickup player rule for single-elimination tournaments, which was approved by the Board in the 11/3/24 Board, be rescinded and that the pickup policy for players in single-elimination tournaments will revert back to current league policy for picking up players. **Motion passed 4-0.** SB will modify applicable rule(s)/policies.
